A Message from your President, Vanessa Lum

RE: 2025 Operating Budget

On November 26, 2024, the Board of Directors of the Villages of Kapolei Association approved the operating budget for the calendar year beginning January 1, 2025. This budget increases the association dues from \$45.00 per month to \$53.00 per month, per lot. There is no change in current road assessments charged to shared roadway and cluster home driveway owners. This approved budget is enclosed for your information.

The last increase in assessments was three years ago in 2022. Since that time our expenses have increased from \$2,950,477.00 to \$3,462,309.00, a 17% increase.

The Board anticipates the following events that will futher impact association revenues and expenses in the future beyond 2025:

- The withdrawal of the State of Hawaii master developer, Hawaii Housing Finance and Development Corporation (HHFDC), currently projected to be fiscal year 2030
- A doubling of the total common element landscaping and associated costs, as a result of HHFDC exiting. This turnover is gradually occuring in process.
- The building of a permanent maintenance shop to house additional equipment. No other capital improvements are anticipated at the present.
- Additional homes added from Kaupea phase 2 and Leiwili Kapolei.

To owners using automatic bill pay through their banks or Property Pay (First Citizens Bank), be sure to change the amount of your payment beginning with the January 1, 2025 payment.

RE: Perimeter Wall

Unfortunately, progress in resolving perimeter wall issues affecting owners of several Villages and properties, including Kumu Iki, Malanai, Aeloa, Kekuilani (except the golf course boundary), Iwalani, Paeko Gardens, Kulalani Village, and Kealakai at Village 6, is not moving as quickly as desired. At the last mediation session with HHFDC held in February 2024, we recommended the hiring of a structural engineering firm agreeable to both parties. In order to seek proposals from structural engineering firms, it is necessary to identify the wall lots by number and map. We requested that HHFDC provide VOKA with a map that identifies the wall lots still owned by HHFDC by lot numbers and that it provide a copy of the deeds (or the document numbers for the deeds) by which HHFDC holds title to the lots. HHFDC recently provided information in response to our request, but the information is not yet complete.

The Board is forming a Perimeter Wall Committee to focus more effort in getting these walls fixed via an agreement with HHFDC. The Perimeter Wall Committee will be made up of at least 9 members, with at least one property owner from each Village that has a perimeter wall. The committee is tasked to contact every affected owner, gather and summarize wall data, and carry out other activities that will support the Board in successfully negotiating with HHFDC and avoid the costly alternative of litigation. The first committee meeting is scheduled for the last week of January 2025.



Christmas Bread with Cranberries

Equipment:

- · large mixing bowl
- stand mixer
- rubber spatula

Ingredients:

- 1 c. milk warmed
- ½ c. butter melted
- ½ c. brown sugar
- 2 eggs
- 4 cups unbleached, all-purpose flour
- 1 tablespoon lemon, zested

- paper moldsheavy duty sł
- heavy duty sheet pan
- wire rack
- 1 teaspoon salt
- 1 tablespoon active dry yeast
- •1 c. dried cranberries
- optional topping of 1 beaten egg white and 2 teaspoons Swedish pearl sugar

Instructions:

To make the dough in a bread machine:

Combine the ingredients in the pan of a bread machine in the order recommended by the manufacturer. Set the dough cycle. Turn it on.

To make the dough in a stand mixer:

1. Combine the milk, butter, and sugar in a medium-size saucepan and warm slightly over medium heat. The mixture should be 105 to 110 degrees F. Transfer the mixture to the mixer bowl and add the yeast. Stir and allow the yeast to proof for 5 minutes. 2. Add the egg, flour, cranberries, lemon zest, and salt. Stir to combine well. Attach the bread hook and knead until a smooth elastic dough is formed, adding ½ to 1 cup flour if necessary. Transfer to a greased bowl and turn the dough ball to coat. Allow to rise until doubled in bulk, about 1 hour.

To make the dough by hand:

1. Combine the milk, butter, and sugar in a medium-size saucepan and warm slightly over medium heat. Transfer the mixture to a mixing bowl and add the yeast. Stir and allow the yeast to proof for 5 minutes. 2. Add the egg, flour, cranberries, lemon zest, and salt. Stir to combine well. 3. Turn the mixture out onto a lightly floured surface and knead for 5 minutes to create a smooth, elastic dough, adding more all-purpose flour as necessary. Transfer to a greased bowl and turn the dough ball to coat. Allow to rise until doubled in bulk, about 1 hour.

To form the loaves:

1. Preheat the oven to 350°. Place two 4-inch panettone paper molds on a baking sheet. 2. When the dough is ready, turn it out onto a lightly floured surface and divide it in two pieces. 3. Form each piece into a tight ball and place in a paper mold. Cover and allow the dough to rise until doubled in bulk, about 45 minutes. 4. Brush the tops of the bread rounds with beaten egg wash and sprinkle with pearl sugar. Bake the breads for 30 to 40 minutes or until golden brown. Test with an instant read thermometer. The center of the bread should be 190 degrees. Cool on a rack before serving.

Notes: Promptly store leftovers in an airtight container for up to 2 days. Nutritional values are approximate, based on ½ of a round of bread, and do not include the optional topping. If you don't have paper molds, form each section of dough into a loaf shape and place each in a traditional loaf pan. Baking time may be on the shorter side.

The Leeward Bikeway is Complete

The Leeward Bikeway has been completed. The Hawai'i Department Transportation announced the completion of the Leeward Bikeway, a dedicated bikeway within the former O'ahu Railway & Land Company rightbetween of-way in 'Ewa and Waipahu trike training program.

Depot Street. The opening of the bikeway was celebrated with a dedication ceremony on Monday, November 25, 2024. The opening of the path expands access for community members to the scenic, natural and historic resources of the Pearl Harbor National Wildlife Refuge.

The new 3.51-mile path connects the previously unconnected West Loch Bike Path and the existing Pearl Harbor Historic Trail. Work included construction of 723 linear feet of

retaining wall, utility relocation; demolition and construction of new bridge structures at Waikele Stream and Kapakahi Stream; paving the nine-to-10-foot path with asphalt concrete; and installation of concrete posts to prevent the use of the bikeway by motorized vehicles.

The Leeward Bikeway is a critical element to complete the statewide pedestrian, bicycle and transit network. The Americans with Disabilities Act compliant bicycle and pedestrian facility will improve safety between 'Ewa and 'Aiea by removing potential for conflict between bicyclists, pedestrians and motorists. This project supports continued residential, business, and commercial growth in the 'Ewa and Central O'ahu areas by providing a non-motorized transportation facility and increased transportation choice.

COVENANTS CORNER

Happy New Year! To all the residents, may you and your Ohana have a safe and prosperous New Year! The Covenants Department would like to thank you for all you do to help make the neighborhood a wonderful place to live. Cheers to a fresh start and new beginnings in the coming year!

CHRISTMAS DECORATION REMOVAL:

We hope that everyone had a wonderful and joyous Holiday Season. Please remember all string lights and decorations must be removed from the exterior of your home by January 15, 2025. Courtesy notices will be issued to residents not in compliance with the specified deadline.

EXTERIOR LIGHTING:

As the new year begins, please make it a priority to check your garage overhead lights, porch entryway lights, and cul de sac lights to make sure they are in working order. The more lighted an area is the less likely according to HPD for criminal activity and theft to take place. If you would like to add any additional lighting, please make sure to put in your application to the Design Review Committee.

TREES, LANDSCAPING, YARDS:

Evaluate your trees and landscaped areas. Prune/cut any trees or shrubs that are blocking public sidewalks or crossing over into your neighbor's yard creating a possible safety hazard or damage to the area. 5.02 (d)

According to the DCC&R, all yards must be healthy, green and maintained in a neat and attractive condition at all times. If you fail to maintain your yard in a neat and attractive condition, you will be placed in violation, which may result in fines and legal action. Watering: should be done between 6 am- 10am. or 5pm-6pm. for 8 to 10 minutes daily to prevent grass from drying out or dying.

Fertilize: involves putting in the right amount of nutrients that your lawn needs. Please be sure to follow the instructions for the fertilizer that you choose to use.

MODIFICATIONS TO YOUR PROPERTY

Our Covenants Specialist have noticed an increase in modifications made to properties without getting approval from the Design Review Committee. It is very important applications for modifications are submitted, not only to have record of them for your files, but to also be sure it is an approvable item within the Villages of Kapolei. We want to avoid homeowners making purchases or spending money on items that may not get approved. You can contact the Covenants Department with your questions on modifications and how to submit your request. Our Design Review Application and Guidelines can also be found on our website at www.villagesofkapolei.com. Please keep in mind, ANYTHING done to the exterior of the property (front or behind your

fenced area) needs to be applied for. 5.05 (b)

What are the Associations' procedures for not following the DCC&R, Design and Landscaping Guidelines?

The Association has procedures for unkept lots, properties in Foreclosure, structures built upon a lot without the approval of the Design Review Committee and structures that do not meet City & County building code requirements. Homeowners contact our office regularly, questioning what the Association is doing about various lots that are unkept. The Association informs all concerned homeowners that we have procedures, they are as follows:

- A courtesy notice to the homeowner, stating they are in violation of the DCC&Rs (violation must be corrected within seven – fourteen days).
- A second courtesy notice to the homeowner, stating that said violation has not been corrected (violation must be corrected within seven - fourteen days of second notice).
- A fine notice and invoice for \$50.00 to the homeowner, stating that they were notified previously and said violation has not been corrected (the invoice will be effective and posted on the 14th day of notice if not corrected).
- 4. A \$100.00 fine invoice and notice stating said violation to the homeowner (the invoice will be effective and posted on the 30th day of notice if not corrected).
- A \$200.00 fine notice and invoice to the homeowner (the invoice will be effective on the 30th day of notice if not corrected).
- 6. Lastly, the homeowner has been forwarded to our Attorney for legal action that may result in a Lien against said property and possible Foreclosure proceedings. Once subject property has been forwarded to legal, our attorney then contacts homeowner of said property and notifies them of violations upon their lot. All Attorney fees and fines are posted to said homeowner's account. If a homeowner fails to pay posted fines and dues, a lien is then placed against subject property. A lien against a property prevents a homeowner from refinancing, borrowing money against subject property (second mortgage) or makes it very difficult to sell subject property without correcting said violation. If a homeowner fails to comply and/or pay their account, the Association may seek a judgement against said owner, which may result in the garnishment of wages. If a homeowner still disregards all notices and refuses to pay all charges on their Association account, the Association will then proceed with Foreclosure. The Association will work with every homeowner in violation to prevent legal action

PRIORITY OF PAYMENT:

Homeowners, please take the time to understand how your payments made to the Villages of Kapolei Association are processed. If a homeowner has any legal fees or collections, late fees, interest, house rule fines, road assessments, or covenants legal fees, any payments made for dues will go towards the outstanding items first and then be applied to the dues and road assessments. 8.06 (f)



LEGISLATIVE SESSION 2025

The 2025 Hawai'i State Legislative Session begins January 15, (which also happens to be my body's 77th birthday). This is a time to unite and focus on addressing critical issues for our islands. As I enter my 9th year as Chair of the Agriculture and Environment Committee, I've been engaging with agricultural and environmental leaders statewide to explore ways to boost local food production and enhance food security. This legislative session provides a meaningful opportunity for residents, advocates, and legislators to collaborate on crafting policies that reflect Hawai'i's culture, values, and needs. Mahalo to all contributing to this vital work!

As the first year of the biennium, Opening Day will be a festive occasion with opportunities to visit legislators' offices and enjoy refreshments.

THE HAWAI'I LEGISLATIVE BIENNIUM

The biennium refers to the two-year cycle during which the Hawai'i State Legislature conducts its work, consisting of two sessions:

- 1. **The First Regular Session** (odd-numbereyears, e.g., 2025) focuses on introducing new bills, setting the budget, and tackling broad legislative goals.
- 2. **The Second Regular Session** (evennumbered years, e.g., 2026) continues unfinished work, revisits earlier bills, and addresses urgent matters.

Both sessions run for 60 legislative days,

excluding weekends and holidays, making for an intense and productive period of governance. I welcome your bill ideas and feedback on legislation during the session. Join my mailing list to stay updated on legislative and community news!
